## **Quiz Answers**

- 1. True Although self-regulation is constrained by legislation and regulation.
- 2. False Regulation of health professions occurs at the provincial level.
- 3. *True* The *Health Professions Act* states the key regulatory responsibilities of a College, which relate to: registration and practice permits; professional practice standards; continuing competence; and professional conduct.
- 4. False Professional titles are not portable. A healthcare professional must be registered in the province where they want to practice in order to have the right to use the protected titles for their profession.
- 5. True Regulated members with a doctoral degree must apply to the College and obtain authorization to use the title "Doctor" in association with providing a health service to the public.
- 6. False This is done by Standards of Practice. Practice statements describe in plain language, the day-to-day practice of a particular health profession.
- 7. True The Health Professions Act prohibits a College from setting or negotiating professional fees, or from being a certified bargaining agent.
- 8. *True* The *Health Professions Act* states that at least 25% of the voting members of a governing council must be members of the public.
- 9. False ACSLPA protects the public by ensuring that only qualified applicants are registered; making the General Register available to the public; enforcing standards of practice; establishing a continuing competence program; and investigating complaints into the practice of a regulated member.
- 10. True The Health Professions Act, Protection for Persons in Care Act and Child, Youth & Family Enhancement Act state circumstances where there is a duty to report information to the proper authority.
