### **Quiz Questions on Registration**

1. Employers are prohibited by law from knowingly employing any individual who is required to be registered with the College but is not.

2. Mandatory registration requirements are only applicable to those in clinical practice.

3. Individuals volunteering their SLP or audiology professional services are exempt from mandatory registration.

4. The General Register includes those SLPs and audiologists who are entitled to practice and use the protected titles of their profession in Alberta.

5. Individuals with *Non-Practicing* status may volunteer as an SLP or audiologist and continue to use the protected titles of their profession. They must use the term "Non-Practicing" in parentheses following their title.

6. A practice permit must be on display or made available for inspection upon the request of employers or the public.

### **Quiz Answers**

- 1. *True* The employer may be guilty of an offence and may be subject to a fine and possible imprisonment.
- 2. *False* An SLP or audiologist who teaches or conducts research related to their profession in Alberta must be registered, even if they are not involved in clinical practice.
- 3. *False* Mandatory registration requirements apply regardless of whether an individual engages in paid employment or volunteers, or practices full-time, part-time or on a casual basis.
- 4. True
- 5. *True Non-Practicing* members may NOT practice or volunteer but can use protected titles as long as they have "(Non-Practicing)" after their title.
- 6. *True* Regulated members are able to print their practice permit by accessing their Member Login on the ACSLPA website.
- 7. *False* Members must change their status to *Registered* PRIOR to beginning to work or volunteering in their profession.
- 8. *False* Labour mobility legislation applies to regulatory bodies only.
- 9. *False* The individual must meet ALL the registration requirements in place at the time of their application. This means education, current practice and examination requirements.
- 10. *True* The *Health Professions Act* requires a college to notify an employer when a practice permit is suspended or conditions are applied.
