4 7.1 Restricted Activities Performed by Regulated Members

- 5 A regulated member of ACSLPA performs only those restricted activities that they are authorized
- 6 and **competent** to perform in compliance with legislation and with <u>ACSLPA *Standard of Practice 4.4*</u>
- 7 <u>Clinical Supervision</u>.

8 Indicators

- 9 To demonstrate this standard, the regulated member will:
- a) Familiarize themselves with the activities they perform that are restricted activities, including
 procedures or episodes of care that involve restricted activities, under the *Health Professions Act*,
- b) Limit themselves, when performing restricted activities to those activities that they are
 competent to perform and to those that are appropriate to their scope of practice and the
 procedure being performed.
- 16 c) Assess the risks and benefits associated with the restricted activity, and
 - (i) communicate these to clients, and
- 18 (ii) adjust their service plans accordingly to mitigate risks and enhance benefits.
- d) Monitor their application of restricted activities and be accountable for their actions and
 decision-making, and
- e) Ensure that appropriate strategies are in place to address any critical or unexpected occurrences
 associated with the application of restricted activities.

24 7.2 Supervision of Others by Regulated Members

- A regulated member of ACSLPA takes professional responsibility for the work of those who perform restricted activities under their **supervision**, direction, or control, namely:
- a) speech-language pathology and audiology students,
- b) speech-language pathologists and audiologists who require a period of supervised practice to
 meet a condition on their practice permit, and
- 30 c) support personnel.
- 31 Regulated members provide appropriate supervision to the individuals listed above in relation to the
- 32 performance of restricted activities, including procedures or episodes of care that involve restricted
- 33 activities. A listing of procedures that involve restricted activities that speech-language pathologists and
- 34 audiologists are authorized to perform in Alberta is available as part of ACSLPA's Restricted Activity
- 35 <u>Competency Profiles</u>.

36 Indicators

- 37 To demonstrate this standard, the regulated member will:
- 38 a) meet the requirements of 7.1 (above),
- b) have a minimum of one year of experience in performing the restricted activity,
- 40 c) meet all the requirements outlined in ACSLPA Standard of Practice 4.4 *Clinical Supervision*.
- Particularly, the regulated member will not assign restricted activities or procedures that involve
 restricted activities involving clinical interpretation to support personnel, as outlined in Standard
 4.4 indicator d) i.
- 44 d) determine and provide the degree of **direct** and/or **indirect supervision** that, in the regulated 45 member's opinion, is commensurate with the supervisee's competence.
- 46 e) be available either in person or virtually (i.e., telephone, video conference) for consultation while
 47 the supervisee performs the restricted activity, as required.

48 **7.3 Expected Outcomes**

- 49 **Clients** can expect that the regulated member and anyone under their supervision has the required
- 50 competence to perform restricted activities safely and effectively.

59 **Glossary terms**:

- 60 **Client** refers to "a recipient of speech-language pathology or audiology services, and may be an
- individual, family, group, community or population". An individual client may also be referred to as apatient.
- 63 Competence/competent/competency refers to "the combined knowledge, skills, attitudes and
 64 judgement required to provide professional services".
- 65 **Regulated member** refers to "an individual who is registered with ACSLPA in any categories of 66 membership prescribed in the Regulation and in the ACSLPA Bylaws".
- 67 **Restricted activities** refer to "procedures or services that pose significant risk and require a high level of
- 68 professional competence to be performed safely. Restricted activities may only be performed by
- 69 persons authorized by their regulatory college to do so".
- 70 Restricted activities for SLPs include to:
- Insert air or gas under pressure into the ear canal,
- Insert or remove instruments or devices beyond the point in the nasal passages where they
 normally narrow,
- Insert or remove instruments or devices beyond the pharynx,
- Insert or remove instruments or devices into an artificial opening into the body, and
- Administer diagnostic imaging contrast agents.
- 77 Restricted activities for audiologists include to:
- Insert or remove instruments, devices, fingers or hands beyond the cartilaginous portion of the
 ear canal,
- Insert air or gas under pressure into the ear canal, and
- Insert a substance that subsequently solidifies into the ear canal.
- 82 **Supervision** refers to "a dynamic and evolving process involving the oversight of another's work.
- 83 Regardless of the relationship, the purpose of supervision is to help ensure the delivery of competent,
- safe and ethical speech-language and audiology services. As part of the supervision process, the
- supervisee remains responsible and accountable for their own actions.

- 86 **Direct supervision** refers to "the supervising SLP or audiologist being physically present within the
- 87 environment or virtually present via real-time videoconferencing. The SLP or audiologist observes the
- supervisee carry out the assigned activity and can provide immediate feedback, redirection, and
- 89 modeling as necessary".
- 90 Indirect supervision refers to "the supervising SLP or audiologist not being physically or virtually present
- 91 when an assigned activity is being carried out. The SLP or audiologist monitors and evaluates the
- ⁹² supervisee's performance of assigned activities by reviewing audio/video recordings, written records,
- and/or through discussions with the supervisee, clients, family, caregivers, team members,
- 94 and /or employers.
- 95 **Support personnel** refers to "individuals who, following academic and/or on-the-job training, perform
- 96 activities that are assigned and supervised by a speech-language pathologist or audiologist registered
- 97 with ACSLPA. Individuals functioning as support personnel may have a variety of working titles. This
- 98 excludes teachers, volunteers, students training in speech-language pathology and audiology, and
- 99 family members".
